Instructions:

- Please be polite when scheduling your appointment.
- Do not call before 8 AM or after 9 PM.
- If you leave a message, speak slowly and clearly.
 - Include your name and phone number.
- Only schedule with one tester.
 - If you make another appointment, make sure to cancel any other appointment.
- Be courteous. If you find you cannot make your appointment, notify the tester.
- Be considerate by being on time for your test. If you are going to be late, notify the tester. You may have to reschedule your test.

At your test, you must provide:

- A motorcycle with current registration and proof of insurance (*required*),
 - Testing on a modified bike or a bike with knobby tires is more difficult.
- \$10.00 Skills Tester Fee (*cash only & correct change*),
- **Signed receipt** from a licensing office that shows the completion of the motorcycle written test.

Basic vehicle control and obstacle-avoidance skills are included in the skills test to determine your ability to handle normal and hazardous traffic situations.

You will be tested on:

- Normal Stops
- Sharp Turns
- Obstacle Swerve
- Not-Stalling the Motorcycle
- Quick Stop
- U-Turn
- Cone Weave

You are not required to test in the county where you reside.
