- You must provide:**
- A signed receipt from the licensing office showing completion of motorcycle written test
  - The motorcycle (testing on a modified bike or a bike with knobby tires is more difficult)
  - Proof of current registration and **insurance** for the motorcycle being used for the skills test
  - \$10.00 Skills Tester Fee (**cash**) <correct change>

Basic vehicle control and obstacle-avoidance skills are included in the skills test to determine your ability to handle normal and hazardous traffic situations.

- You will be tested on:**
- Sharp Turn
  - Normal Stop
  - Obstacle Swerve
  - Cone Weave
  - U-Turn
  - Quick Stop
  - Not-Stalling the Motorcycle

**Notes:**

- **Please be courteous when scheduling your appointment**
- **Do not call after 9 PM or before 8 AM**
- **Speak clearly and include your phone number when leaving a message**
- **Be sure to schedule with only one tester**
- **If you find a more convenient appointment than the one you first scheduled, be sure to cancel any other appointment you have made with another tester**
