### SCHEDULING AN APPOINTMENT:

- Appointments may be scheduled between 8:00 am – 8:00 pm.
  - When leaving a message, include your name and phone number.
  - Calls will not be returned if no message is left.
- Only schedule with one skills test examiner.
  - If another appointment is made, cancel any previous appointment(s).
- If unable to make your appointment, notify the skills test examiner **at least 30 minutes prior** to your scheduled time.
- If you are going to be late, notify the skills test examiner. The appointment may need to be rescheduled.

### YOU MUST PROVIDE THE FOLLOWING TO THE SKILLS TEST EXAMINER:

- **Photo identification** – any state issued driver's license, permit or ID, or student ID, passport, etc.
- A motorcycle with **proof of insurance** (*required*)
- **\$25 Skills Test Examiner Fee** (*cash only & correct change*)
- **Signed receipt** from a county DMV office that shows the completion of the motorcycle written test.

Basic vehicle control and obstacle-avoidance skills are included in the skills test to determine your ability to handle normal and hazardous traffic situations.
