

2018 Motor Carrier Seminars



Who should attend? Commercial motor carriers, farm, logging and agricultural haulers and anyone involved in or with the trucking industry are encouraged to attend. You will have an opportunity to ask questions during the presentations and speak one-on-one with the agency representatives.

Which agencies will be represented? Idaho Transportation Department, Idaho State Tax Commission, Idaho State Police and Federal Motor Carrier Safety Administration.

What are the topics? Vehicle registration including the Idaho North America permanent trailer registration option, Unified Carrier Registration (UCR), hazardous permits and endorsements, Heavy Vehicle Use Tax, overlegal permitting, distance reporting and recordkeeping, audits, IFTA licensing, DOT requirements, roadside enforcement, transponders and more.

What is the cost? There is no charge to attend.
