

## Non-domiciled Commercial Driver's License and Commercial Learner's Permits

For applicants with a limited term status in the U.S., you must provide current/valid legal presence documents such as a:

- Unexpired foreign passport with an I-94 stamp or I-94 form
- Current/valid Employment Authorization Card. New applicants need to bring a foreign passport to establish identity.

*You will not be required to surrender your foreign driver's license.*

## Tips for visiting a county Sheriff's DMV office

To expedite your trip to the DMV and avoid a return trip:

- Bring your proof of citizenship or legal presence
- Only certified original documents will be accepted. No photocopies or laminated documents will be accepted.
- Proof of identify (driver's license or ID card)
- Proof of Idaho residency
- Social Security number
- Proof of name change. *If your name is different from what is on your birth certificate, you will need to bring a certified name-change document such as your marriage license, divorce decree or court order. Multiple documents may be needed if your name has changed more than once.*

# Requirements for Commercial Driver's License

**Do you know what's required to provide proof of U.S. citizenship or legal presence?**



A Commercial Driver's License (CDL) holder or permit (CLP) holder are required to show proof of legal presence and Idaho residency pursuant to federal law. No commercial license or permit may be issued until a driver or applicant provides this information.

#### Four things to know:

- You may provide proof of U.S. citizenship or permanent legal residency when obtaining a license for the first time, or when completing a transfer, upgrade, renewal, or some other change to your record. This includes name, address and endorsement changes.
- **You must provide one of the approved, government issued documents.** (Listed to the right. Birth certificate required, if obtainable). Obtaining replacement documents may take several weeks. If you do not have one of these documents in your possession, you should start the process immediately.
- If you are in the U.S. for a limited time, refer to the back page of this brochure for more information.
- Your legal presence document must be presented to a county Sheriff's DMV office for scanning. You do not need to bring it every time you renew.

## To provide proof of:

### U.S. Citizenship:

you must provide one of the following:

#### **Government issued birth certificate**

Required if obtainable. To obtain a birth certificate, contact your county or state of birth. A hospital issued "Certificate of Live Birth" is not acceptable. Birth certificates issued by the Commonwealth of Puerto Rico before July 1, 2010, are not acceptable.
