# Transporting livestock

### ***If I am hauling livestock, do I need to stop at an Idaho Port of Entry?***

**Yes.** There are two separate requirements.

- All vehicles entering Idaho with livestock must stop at a port of entry or roving port of entry check station. This applies to everyone, not just commercial haulers, regardless of vehicle weight, Idaho Code 25-214(a).
- All farm and commercial vehicles within Idaho weighing more than 26,000 pounds transporting livestock must stop at a port of entry or roving port of entry check station, Idaho Code 40-511.

### ***What is the purpose of a livestock inspection and how long will it take?***

Livestock inspections usually require 10 minutes or less. They:

- Deter theft
- Control the spread of disease
- Ensure trucks and trailers transporting livestock meet Idaho's vehicle safety standards

***Failure to stop could result in a citation and considerable loss of time.***

### ***What animals are considered livestock and what paperwork do I need to enter Idaho?***



#### ***Equine*** – Horses, Asses and Mules

- Certificate of veterinary inspection (CVI).
- Negative Coggins (EIA) test within the past 12 months.
- Brand inspection, registration certificate, or bill of sale.



#### ***Bovidae*** – Cattle, Including Domestic Bison

- Certificate of veterinary inspection (CVI).
- Brucellosis vaccination on all females over four months old.
- Negative trichomoniasis test on all intact males over 18 months old (except bison).
- Negative tuberculosis test on dairy cattle and cattle used for rodeos or timed event.
- All domestic bison and certain other classes of cattle require an entry permit.\*
- Brand inspection, registration certificate or bill of sale.
- Individual, official ID.

\* There may be other permit requirements.



#### ***Domestic Cervidae*** – Deer and Elk

Contact the Idaho State Department of Agriculture for current import requirements.



#### ***Suidae*** – Swine

- Certificate of veterinary inspection on (CVI).
- All breeding swine must have a negative brucellosis test within 30 days of shipment into Idaho or originate from a brucellosis free state.
- Statement that the swine are NOT vaccinated with any PRV.
- Raw Garbage Statement.



#### ***Sheep and Goats***

- For import requirements contact the Idaho Sheep Commission at 208-803-5084.



#### ***Camelidae*** – Llamas, Alpacas, Camels, etc.

Certificate of veterinary inspection (CVI).



#### ***All Birds*** – Including: Ratites – Ostrich, Emu, Rhea. Gallinaceous Birds – Chickens, Turkeys. Captive Waterfowl.

- Certificate of veterinary inspection (CVI).
- All poultry, ratites and waterfowl must either originate from a certified National Poultry Improvement Plan flock or have negative salmonella pullorum-typhoid test within the past 30 days.
