Vehicles over 30 years old that do not qualify for Old Timer plates, as shown below. Vehicle must be in original or authentically-restored condition without major modifications from factory specifications. This vehicle would **not** be considered validly registered without standard registration and should not to be used for commercial or regular personal transportation. **IMPORTANT – See “Use Restrictions” and “Note” on the back of this form.**

☐ **Old Timer**

Vehicles must be manufactured prior to January 1, 1943, in original or authentically-restored condition without major modifications from factory specifications. This vehicle would **not** be considered validly registered without standard registration and should not to be used for commercial or regular personal transportation. **IMPORTANT - See “Use Restrictions” and “Note” on the back of this form.**

☐ **Street Rod**

Vehicles manufactured prior to December 31, 1948, or designed to resemble such a vehicle.
These plates can be personalized (use Personalized Plate Application).

IMPORTANT – See “Note” on back of this form.

☐ **Custom Vehicle -OR- ☐ Custom Motorcycle**

Vehicles with a replica brand title, over 30 years old and that do not qualify for Old Timer plates, as shown above. These plates can be personalized (use Personalized Plate Application).

IMPORTANT – See “Note” on back of this form.

☐ **Year of Manufacture**

Vehicles with model year 1974 and older (except for model years 1969, 1971, 1972, and 1973 which are excluded from this program) may display authentic Idaho license plate manufactured in the same year as the vehicle and for the same type of vehicle. Applicant must supply the plate, plate must be in serviceable condition as originally manufactured. **A color photograph of the plate is required with the application.**

Please Note: Call Special Plates before submitting your application to make sure your license plate number is not already in use by the Year of Manufacture Program. Year of Manufacture plates will become available to other applicants when the registration has been expired for 60 days or more.

Use Restrictions

Classic and Old Timer **plates do not act as a registration** (see Idaho Code 49-401A). Any motor vehicle which qualifies as an "Idaho Old Timer" or an "Idaho Classic" shall only be used for exhibits, parades, tours, club activities and such occasional use as is necessary for operation and maintenance of the vehicle, and shall not be used for business or commercial purposes or as customary and usual transportation. **Registration is required for anyone who intends to operate these vehicles upon any highway in this state.**

Note

Only one plate is required for vehicles registered under the Old Timer, Classic, Year of Manufacture, Custom and Street Rod programs. Plates should be mounted on rear of vehicle.

For Year of Manufacture, Custom and Street Rod programs, vehicles between 8,001-26,000 lbs. require weighted registration. [IC 49-434]
