Study Overview

The Idaho Transportation Department (ITD) hosted a public meeting on Wednesday, Nov. 8, 2023, for the US-95 Spalding and US-12 Arrow bridges over the Clearwater River. The in-person event was held at the Clearwater River Casino and Lodge at Aht'Wy Plaza in Lewiston, Idaho. An online option, presenting the same information as the in-person event, was available starting Nov. 8 with an online feedback survey open through Nov. 22, 2023.

The Clearwater River bridge crossings are important thoroughfares for the traveling public and for the trucking and logging industries. Spalding was built in 1962, and Arrow was built in 1972. Both major river crossings and associated highway intersections require significant improvements to meet current design and safety standards.

ITD is completing an environmental study and preliminary design for each bridge to secure an approved National Environmental Policy Act (NEPA) document. ITD proposes to make changes to enhance traffic flow and improve safety:

- US-95 Spalding Bridge
 - Replace the existing narrow bridge with dual bridges, creating two lanes of traffic in each direction with improved shoulder widths
 - Reconfigure the US-95 and US-12 interchange
- US-12 Arrow Bridge
 - Replace the existing bridge with a new two-lane bridge with wider shoulders
 - Reconfigure the nearby US-12 and SH-3 intersections

The purpose of the public meeting was to share environmental study information and preliminary bridge and roadway designs for both crossings and gather public feedback.

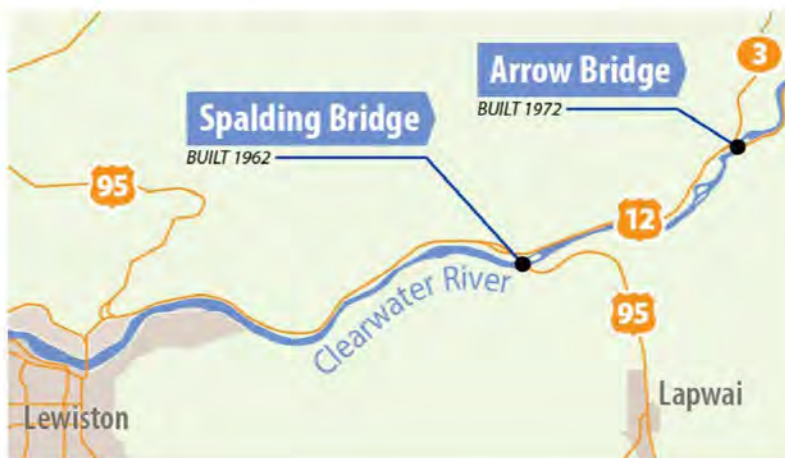

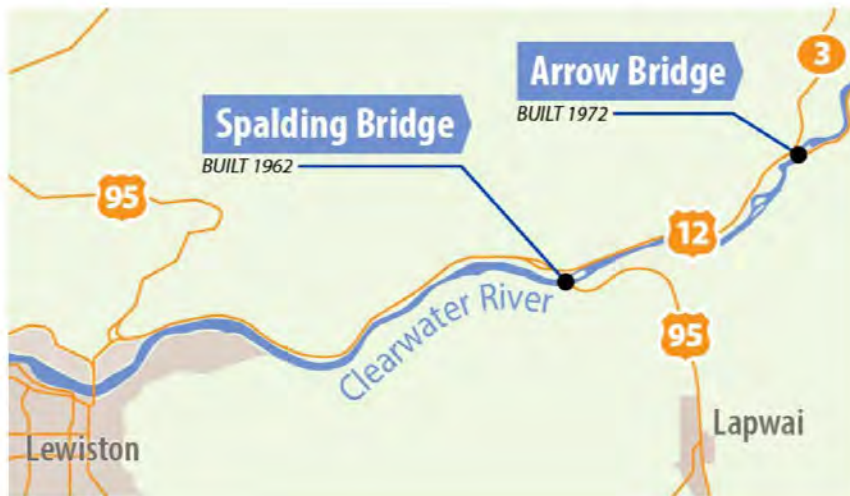

services to report a car crash. "That's what first alerted us to this phone feature. We had all of those resources out there for a false call," Hardin said.

When a real crash occurs, the feature is designed to be a potential lifesaver. The accidental calls are the issue, Hardin said, and the number is on the rise. Agencies have seen a spike in recent weeks since the new iPhone 15 was released.

"Whichever and other 911 dispatchers are not trained to ignore a call, meaning accidental calls caused by the newer iPhone feature have to be dealt with and resources allocated," Hardin said.

"Car crash calls put a lot of emergency vehicles in motion — fire, emergency medical services and police resources."

When a real emergency occurs at the same time, it's "horrible" to have responders tied up with a phony problem, Hardin said. "Dispatch centers are diverting essential resources away from people who need it because of a failure on a phone."

There's a way to prevent the false alarms, the fire chief said. When an iPhone detects a severe car crash, it will display an alert and automatically initiate an emergency phone call after 20 seconds, but the call can be canceled during that time period, if there's no emergency. The feature also can be turned off in settings on the Apple cellphones and watches.

"As these calls increase, we will have to look at the owners of these phones that are sparking false calls, and they could be charged a response fee in the future," Hardin said. "Anyone who has a cellphone with these features should either manage it, or shut the car crash detection off. I don't think people realize the feature is automatically turned on, unless you turn it off."

Another way to prevent flashing lights and sirens from showing up is to immediately return calls from dispatchers or police. If a kid or someone mistakenly dials 911 and hangs up, dispatchers will call the number to find out what's going on. If they don't get an answer, they track down the address and send law enforcement or other first responders, Hardin said.

"Answer your phone," he said. "If you don't answer your phone, we think something is going on. We don't know if you've been in a wreck or are in danger. It costs us all money to roll those vehicles around, and it's a bad deal when we're sending out police, fire trucks and other resources for false alarms."

Officials: Illnesses could be linked to Idaho dairy farm

Local health officials warned that a harmful bacteria may be collected to an Idaho dairy producer after several people became sick.

Central District Health in Boise said it is investigating "reports of illness in five Ada County residents that may be associated with the consumption of unpasteurized (raw) milk."

The health district encompasses Ada, Blaine, Elmore and Valley counties. Since Sept. 20, three of those five residents tested positive for a bacterial infection called campylobacteriosis after drinking milk from Provider Farms in Mountain Home, the district

said in a news release. Provider Farms sells raw milk directly to customers at 10 different locations between Nampa and Burley, according to the company's website. Its products include cow cow's milk, raw goat's milk, cheese, yogurt, eggs and honey.

Provider Farms did not immediately return the Idaho Statesman's request for comment.

As part of its investigation, the health district said it is interviewing symptomatic patients and testing milk samples. The Idaho Department of Health and Welfare is assisting the investigation.

The Idaho State Department of Agriculture is working with Provider Farms to

"mitigate any ongoing risk to consumers," according to the health district. The state agency asked anyone who has purchased raw cow-milk products from Provider Farms in the past 30 days to dispose of them.

Milk is considered raw if it has not gone through a pasteurization process that involves heating milk to kill harmful bacteria, according to the Centers for Disease Control and Prevention.

Central District Health warned that drinking raw milk can pose health risks, particularly to young children, pregnant women, the elderly and those with compromised immune systems. Campylobacteriosis infections usually occur when

campylobacter bacteria spreads to humans through raw or undercooked animal products, according to the World Health Organization. The organization listed diarrhea, abdominal pain, fever, headache, nausea and vomiting as among the infection's most common symptoms, which usually begin two to five days after contact.

Idaho is one of 11 states that allow stores to sell raw milk, with another 18 states allowing it to be sold directly from a farmer, according to legal group Farm to Consumer Legal Defense Fund. Proponents say drinking unpasteurized milk provides a variety of health benefits, though many medical experts dispute this.

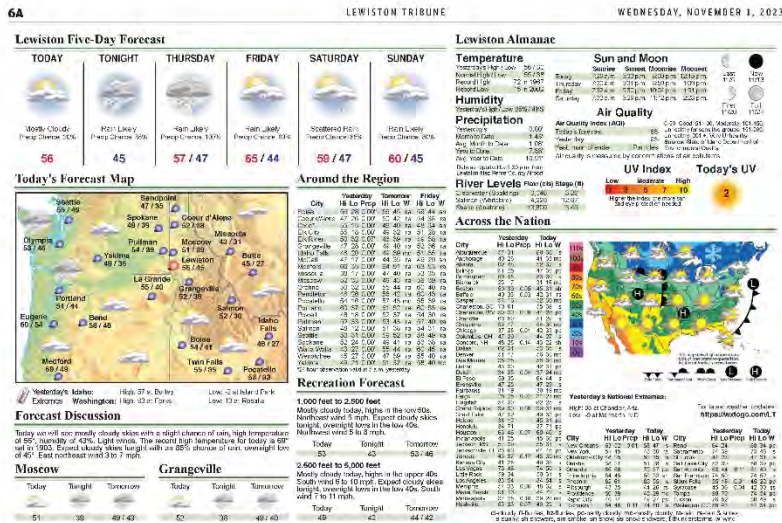

NEW YORK — Actor Robert De Niro shouted "Shame on you!" as he testified Tuesday in a New York courtroom, directing the comments toward his former executive assistant and vice president who seeks millions of dollars after accusing her onetime boss of being abusive.

Graham Chase Robinson watched with her lawyers while De Niro's anger built as attorney Andrew Macurdy pelted him with some talk-show-style accusations his client made about De Niro's behavior toward Robinson as she served his needs, large and small, from 2008 until several months into 2019.

Robinson, 41, seeks \$12 million in damages for emotional distress and reputational harm that she claims have left her jobless and unable to recover from the trauma of working for De Niro. She was making \$300,000 annually when she quit, frustrated by her interactions with De Niro's girlfriend and the effect she believed the girlfriend was having on the actor.

The jury is also considering evidence pertaining to a lawsuit De Niro filed against Robinson in which he claimed that she stole things from him, including 5 million points that could be used for airline flights. De Niro is seeking the return of three years of Robinson's salary. Macurdy asked De Niro whether it was true that

he sometimes urinated as he spoke with Robinson on the telephone.

"That's nonsense," De Niro answered. "You got us all here for this?"

Macurdy told De Niro he called Robinson "b**** to her face."

"I was never abusive, ever," the actor snapped back, through he conceded that he might have used the word in conversations with her.

And the claim that he told Robinson he preferred that she scratch his back rather than using a back scratching device drew another angry rebuke from De Niro, who said it might have happened once or twice, but "never was with

disrespect or lewdness."

Finally, he angrily looked toward Robinson and shouted: "Shame on you, Chase Robinson!"

Quickly, he blurted an apology in a quieter voice, as he glanced toward Judge Lewis J. Liana.

The actor admitted that there were no written rules for those who worked for him because, he said, he relied on the "rules of common sense."

He said he promoted Robinson with the title of vice president of his company, Canal Productions, at her request but he added that her duties didn't change.

At times, De Niro would flatly deny something, only to later admit that

there might be truth to it in a manner different than how it was suggested.

Asked if he once yelled at Robinson when she was in Europe and had failed to call and remind him of an important meeting in California, he Niro answered that he hadn't, only to quickly add: "I raised my voice."

"I got angry that one time," he said. "I berated her. I wasn't abusive. I was upset."

"You called her a brat," Macurdy said. "I could have."

De Niro answered.

Sometimes, De Niro sounded like he wanted to leave the witness stand.

"I don't have time for this," he said at one point.

Striking actors' latest scare tactic? Halloween pickets and clever costumes

LOS ANGELES — Witches, black cats, Jack-o'-lanterns, spiders, crows and vampires lined up outside Netflix's offices in Los Angeles this week in the latest group effort by striking actors to speak the major Hollywood studios into agreeing to their terms and bringing an end to the work stoppage that has limited the entertainment industry for months.

The performers union, SAG-AFTRA, hosted two Halloween pickets on Tuesday, "Double, Double, Toil and Trouble!" at Netflix and "Spooky Solidarity Day" at the Warner Bros. studio lot in Burbank.

During the holiday demonstrations, guild members showed their commitment to the cause by donning disguises that fit the theme while abiding by the union's widely praised costume guidelines — which advised members to avoid looks "inspired by struck content."

"The Rose the Picketeer," said Steve Nelson, a SAG-AFTRA senior captain who wore a blue denim shirt and a red bandana resembling Rosie the Riveter outside of the Netflix building on Van Ness Avenue.

"I thought it would be a fun costume for the picket today, just because she's a (working) gal, and it was easy to do," said Nelson. "I was like, 'It's gonna be hot out. Let's just do something that's light weight and looks good to be in.'"

Nelson was among several members of the Screen Actors Guild-American Federation of Television and Radio Actors who showed up at Netflix on Tuesday in creative, homemade costumes. One demonstrator, Martin Pines, came dressed as SAG-AFTRA President Fran Drescher's "The Nanny" character.

"This wasn't even going to be my costume for this year, but with the strike I figured I should go with something that is topical," said Pines, who strutted up and down the sidewalk in black tights, ruby heels, a red coat with chestnut-pink lining (swept on by his mother) and a sky-high, curly brown wig.



Officials look to replace bridges

Nov. 9—The Idaho Transportation Department is preparing a multi-year, \$200 million effort to replace the Spalding and Arrow bridges east of Lewiston.

The state agency is in the initial stages of environmental analysis and is seeking public comments on the work that could begin late next year and run through 2029. Project manager Mark Campbell said each rebuild carries an estimated cost

around \$100 million and the state hopes to pay for them through the sale of Transportation Expansion and Congestion Mitigation (TECM) bonds.

However, the department is leaving the door open for the possibility of federal funding. Because of that, it is preparing a National Environmental Policy Act analysis for each rebuild. The law requires agencies to examine the environmental impacts of major federal actions. That includes state projects that are paid for in whole or in part with federal dollars.

"Right now, we are using the TECM funds, which is all state. But in the future this very well could have at least some federal funds on it. So just to be sure, we are following federal guidelines," Campbell said.

The projects have the potential to negatively affect habitat for threatened and endangered salmon and steelhead and other aquatic species in the Clearwater River. Both bridges are on the Nez Perce Indian Reservation and in areas with heavy historic use by the tribe. Because of that, the analysis will also look at the potential for the projects to affect tribal cultural resources.

Spalding Bridge is on U.S. Highway 95 and Arrow Bridge is on U.S. Highway 12.

Campbell said the plans call for Spalding Bridge to be replaced with a pair of two-lane spans and for Arrow Bridge to be replaced with a wider bridge.

The new bridges will be constructed offline — meaning adjacent to the existing bridges that will remain in use during construction. Once they are finished, the old bridges will be removed.

"Because of how these bridges are going to get built, pretty much offline, we would really like to see them built at the same time," said Campbell. "The impact to traffic is going to be very minimal."

Transportation officials held a public meeting about the projects at the Clearwater River Casino on Wednesday, when they answered questions and collected comments. A virtual version of the meeting is available at itdclearwatercrossings.com/.

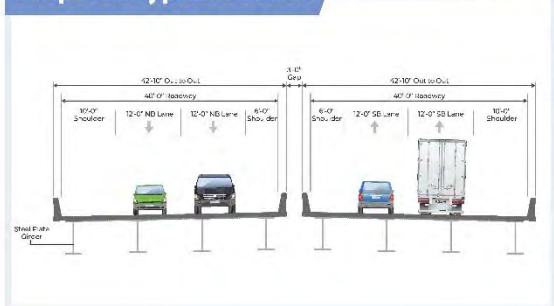

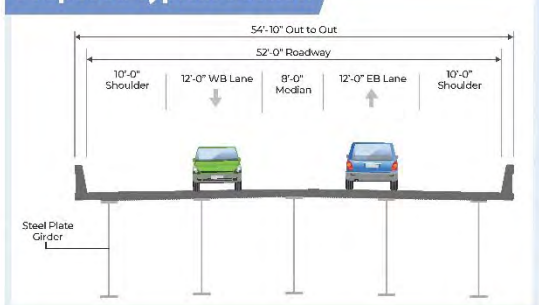

Leading Idaho TECM Program

To address the state's rapid growth, the Idaho Legislature passed a historic transportation revenue package that Governor Little signed as part of his **"Leading Idaho"** initiative in May 2021.

The Legislation transfers \$80 million dollars a year in the Idaho **Transportation Department's Transportation Expansion and Congestion Mitigation** (TECM) fund. Leveraging these TECM funds as debt service on bonds could yield as much as \$1.2-1.5 billion in improvements.

Projects in TECM corridors will accelerate the construction of critical transportation improvements that would otherwise take many years to build, reduce congestion, improve safety and modernize aging roads and bridges across Idaho.

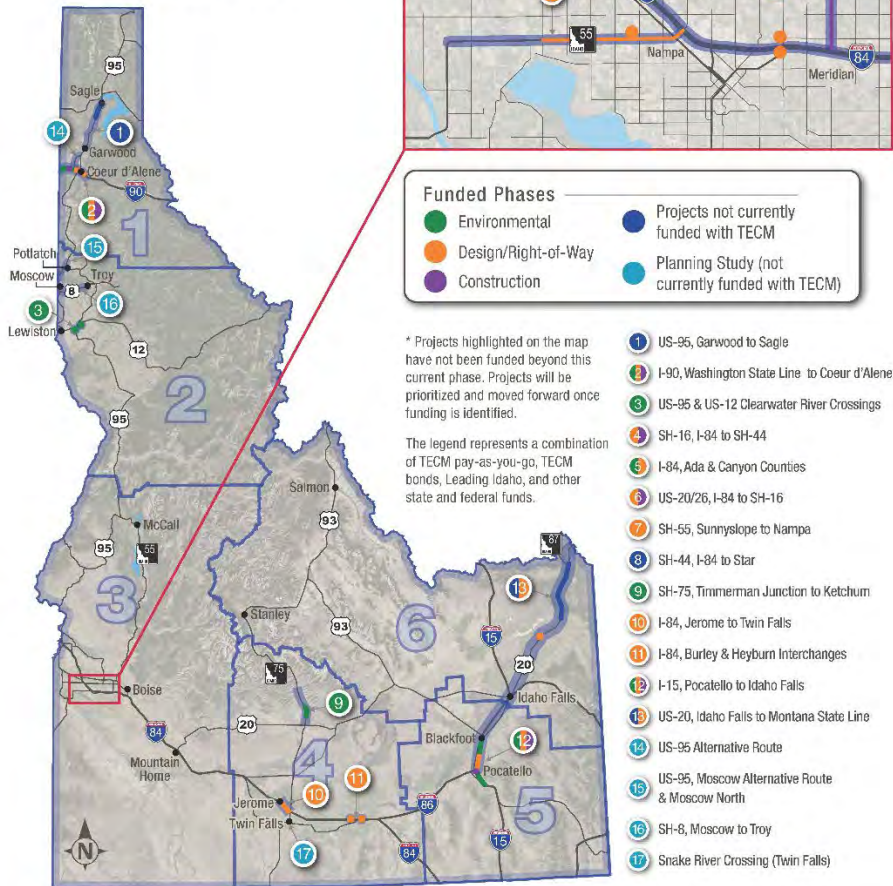

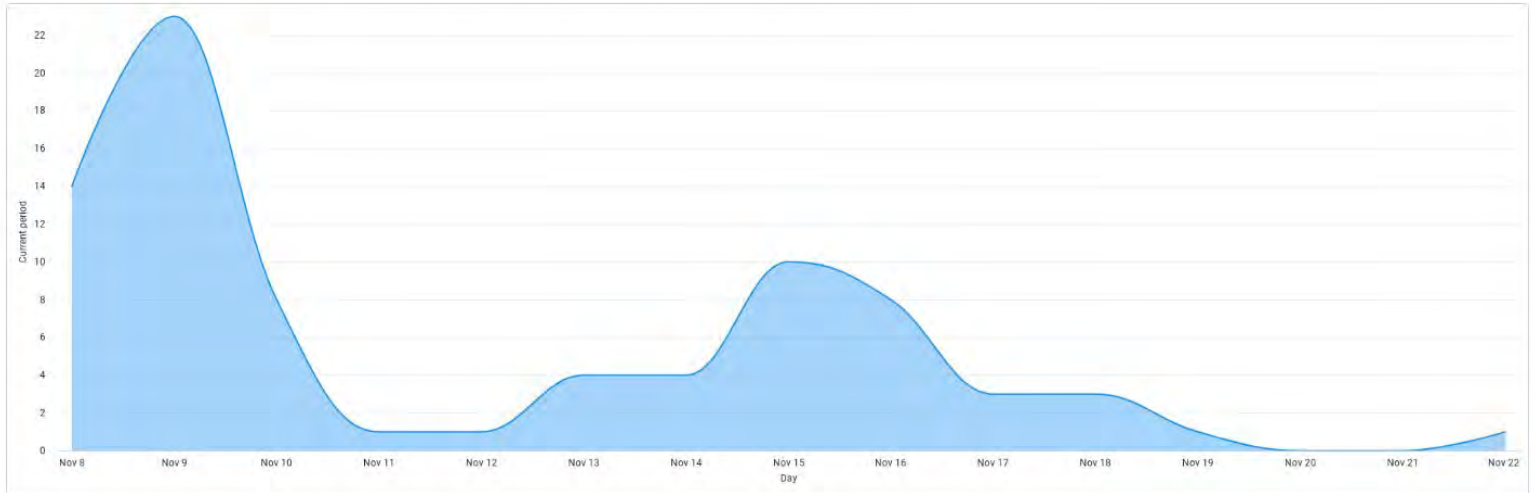

SAFETY & DESIGN QUESTIONS

1. Can the speed limit be reduced on US-95 and US-12 for safety?

The Idaho Transportation Department (ITD) does not plan to decrease the speed limits. Speed limits on key routes are reviewed every other year and are set based on the speed most drivers are traveling. The speed limit will be evaluated as part of the design phase of the project in 2024. Additionally, the new project designs for both bridges and the associated highways have been developed to support the current speeds. Artificially reducing the speed limit requires the consistent presence of law enforcement and proves to be less safe than allowing traffic to flow consistently.

2. What are the design features of the Spalding bridge and associated highway intersections project?

At this time, the Spalding bridge has been designed only to the level needed to assist the team with the environmental study process. This means that this preliminary design simply includes features to allow the existing roadways to meet current design and safety standards. Feedback received from the public at this early stage is helpful and will be considered by the team as the study transitions into a more detailed design project. This design will:

- a. Replace the existing narrow bridge with dual bridges, creating two lanes of traffic in each direction with improved shoulder widths
- b. Reconfigure the US-95 and US-12 interchange
- c. Provide additional vertical clearance on the US-95 bridge over US-12
- d. Provide dedicated turn lanes onto Mullay Road and Sampson Road
- e. Update signage

3. What are the features of the Arrow bridge and associated highway intersections project?

At this time, the Arrow bridge has been designed only to the level needed to assist the team with the environmental study process. This means that this preliminary design simply includes features to allow the existing roadways to meet current design and safety standards. Feedback received from the public at this early stage is helpful and will be considered by the team as the study transitions into a more detailed design project. This design will:

- a. Replace the existing bridge with a new two-lane bridge with wider shoulders and a center median
- b. Reconfigure the nearby US-12 and SH-3 intersections
- c. Provide a safer opportunity for turning onto Awesome Lane
- d. Update signage

4. How do the design features of the two bridges enhance safety?

Proposed changes to the bridges and nearby highway intersections would improve traffic flow and enhance safety for present and future roadway users. The benefits include:

- a. **Wider shoulders** with room for bicyclists, pedestrians, and space for emergency responders
- b. **Smoother curves** at intersections that are easier to navigate for towing vehicles and logging trucks
- c. **Increased sight lines** and longer merging distances improve safety

- d. **Dedicated turn lanes** improve traffic flow

5. Will the projects have pedestrian facilities?

The projects have been designed with outside shoulders that are 10 feet wide to enhance safety and provide room for all users, including bicyclists, pedestrians, and emergency responders.

6. How does it help to widen to four lanes over Spalding when it still merges into two lanes south of the bridge?

ITD understands that these projects are part of a larger roadway network that can only be improved incrementally. Being built over 50 years ago, the Spalding Bridge structure needs improvements to meet current design and safety requirements now. The Transportation Expansion and Congestion Mitigation (TECM) program provides a unique opportunity for ITD to address these critical infrastructure needs and build a bridge that is appropriately sized for anticipated traffic counts in the next few decades. Additionally, having four lanes over Spalding provides a safe opportunity for bridge maintenance and inspection while maintaining mobility for the traveling public.

PROCESS QUESTIONS

7. Why were these two bridges chosen?

The Spalding and Arrow bridges were built over 50 years ago and require improvements to meet current design and safety standards. The environmental evaluations, which include preliminary design concepts for each bridge, were chosen to be funded through the TECM program, not only because of the infrastructure needs, but also because they are important regional connections for commerce.

The TECM program is part of Governor Little's Leading Idaho initiative that allows ITD to accelerate project timelines to address rapid growth and build critical infrastructure today that would otherwise take many years to fund and build. Construction is not currently funded for either bridge.

8. How does the right-of-way process work?

Property owners are consulted during the design process, including an initial contact when all impacts may not be known or for certain. Communication continues throughout the design process until it is ready to be constructed. Most projects are planned seven years in advance. Before land or easements are purchased, independent appraisals will be conducted, and owners will have the chance to negotiate. The department pays fair market value for impacts.

The right-of-way section of ITD is responsible for the acquisition of all property required for highway construction, material sources, and maintenance shed sites. For more information about the ROW process, please visit <https://itd.idaho.gov/row>.

9. Will Tribal members get to work on both bridges?

With Spalding and Arrow Bridges both being located on the Tribal reservation, the Tribal Employment Rights Ordinance (TERO) requires that employers give employment preference to qualified Native Americans if the project receives federal funding. ITD encourages interested Tribal members to contact the applicable TERO Office (itd.idaho.gov/civilrights) for further information or call the ITD Office of Civil Rights, 208-334-8884.

10. Why was the public meeting an open house format?

The public meeting was designed in an open house format to allow participants to navigate the display materials on their own timeline and ask questions as they pleased. The meeting was intended to provide information about the environmental study process and preliminary bridge and roadway designs for both the Spalding and Arrow project areas. Detailed designs will be developed in 2024, and we look forward to including the public, stakeholders, and community representatives in that process as it moves forward.

While I believe this is long overdue I also believe that considerations should be considered for the people whose land ~~is~~ is being taken. I have no idea if the land is being taken by "Innate Domain" but I assure so. Once the land is ~~is~~ taken it should be taken care of. My home is on a straight away and traffic is fast and dangerous. So I used my own weed whacker to cut down the tall grasses that grow near the intersection of my home so we could safely enter and leave traffic lanes. Care should be taken to make sure that people have a good ~~enough~~ view to see ahead of them in traffic, so they can be aware of other vehicles, emergency vehicles and trucks.

Also ~~I~~ I believe that the speed limit should be reduced on the bridges. As a resident of the area for at least 13 years. I notice that many people drive ~~are~~ well over the posted speed limit, most especially trucks. I get it that they have a job and want to get it done. I believe that a lower speed limit should be enforced to keep all drivers safe. Crossing the bridge now is scary and dangerous for drivers because of just how fast trucks especially drive. The reason for short lifespan of the bridges is a familiar problem. The crumbling concrete and excessive oxidation indicate saline erosion. Does the road crew use salt when they sand the highway? Salt will not hurt the asphalt but it is poison on concrete and steel. It may be a major player in the fish situation also. Let me explain this. Record returns are corresponding with drought conditions. At the confluence of the Clearwater and Snake the fish always seem to gather. This may be to determine which stream is least saline. In a drought year there is less rain to wash the salt from the edge of the road into the river. The fish have left the salt water to spawn in fresh water so they know the difference. The road is closer to the Clearwater in more places than the Snake or Salmon rivers. How much of a hardship would it be to use something besides salt?
